STATE OF NEVADA, WASTEWATER CERTIFICATION RENEWAL CYCLE INFORMATION

When you renew, ensure your application is complete. You must submit:

1. The Renewal Application;

- 2. A check for \$110 or a properly processed e-payment receipt (attach it or write the confirmation number on front of application); and
- 3. Copies of certificates for contact hours earned during the two year cycle in which the certificate was in force. Please, make sure the application is filled out **completely**.

A few notes to make processing your application faster:

- 1. Fill out all pages of the application. Be sure to *sign and date* the second page.
- 2. Submit copies of certificates from contact hours earned during the two year cycle in which the certificate was active.
 - a. Grade I operators are required to submit 5 hours of preapproved training.
 - b. Grade II operators are required to submit 10 hours of preapproved training.
 - c. Grade III operators are required to submit 15 hours of preapproved training.
 - d. Grade IV and V operators are required to submit 20 hours of preapproved training.

 Contact or training hours are not transferrable to more than one certificate renewal.
- 3. Submit your application **early, if** we need clarification, we will strive to contact you prior to the deadline date. If you wait to submit until due date and we find your application to be non-approvable, you risk having to reinstate with penalty costs incurred.
- 4. **YOU** should review your application for completeness/accuracy before you sign it, especially if someone else filled it out for you. **Your operator certification is a license to work**. It only takes a few minutes to review your application to make sure it is accurate and complete.
