



**NOTICE OF PUBLIC WORKSHOPS  
Proposed Regulation P2020-01 and P2020-02  
Nevada Division of Environmental Protection  
January 13, 2020**

The Nevada Division of Environmental Protection (NDEP) is proposing to adopt regulations (P2020-01 and P2020-02) amending Chapter 445A, 445B and Chapter 459 of the Nevada Administrative Code (NAC). Specifically P2020-01 addresses sections of NAC 445A.2862, 445A.2866, 445A.2868, 445A.287, 445A.289, and 445A.2912; and P2020-02 addresses NAC 445A.293, 445A.646, 445A.647, 445A.652, 459.9729, and NAC 445B.

The proposed regulatory revisions (P2020-01) are making changes to the wastewater treatment operator certification program. This proposal revises the initial education requirement for Grade I and Grade II from 60/120 contact hours to 50/100 contact hours. This proposal also addresses the restricted certificate to change it from a non-renewable certification to one that can be renewed every two years with the addition of contact hours. A treatment plant classification for “facultative ponds” is added. Renewal fees are affected.

The proposed regulatory revisions (P2020-02) are making changes to certification programs contained in three bureaus within NDEP (Water Pollution Control in NAC 445A, Safe Drinking Water in NAC 445A, and Corrective Actions in NAC 459). The proposal adds due process procedures for when NDEP initiates disciplinary action for individuals who are Wastewater Operators, Drinking Water Operators, Certified Environmental Managers, Certified Tank Handlers or Certified Tank Testers. The Agency Draft proposed regulatory revision suggests that the new regulations be housed in 445B to address all three certification programs and makes related changes in NAC 445A and 459.
